TERMS OF SERVICE:

The following terms and conditions govern all use of the Audramichelle.us website and all content, services and products available at or through the website (taken together, the Website). The Website is owned and operated by Audra Michelle Custodio ("Audra Michelle Custodio"). The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Audra Michelle Custodio Privacy Policy) and procedures that may be published from time to time on this Site by Audra Michelle Custodio (collectively, the "Agreement").

Please read this Agreement carefully before accessing or using the Website. By accessing or using any part of the web site, you agree to become bound by the terms and conditions of this agreement. If you do not agree to all the terms and conditions of this agreement, then you may not access the Website or use any services. If these terms and conditions are considered an offer by Audra Michelle Custodio, acceptance is expressly limited to these terms. The prevailing party in any action or proceeding to enforce this Agreement shall be entitled to costs and attorneys' fees. If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties' original intent, and the remaining portions will remain in full force and effect. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. You may assign your rights under this Agreement to any party that consents to, and agrees to be bound by, its terms and conditions; Audra Michelle Custodio may assign its rights under this Agreement without condition. PRIVACY POLICY:

Audra Michelle Custodio ("Audra Michelle Custodio") operates Audramichelle.us and may operate other websites. It is Audra Michelle Custodio policy to respect your privacy regarding any information we may collect while operating our websites.

WEBSITE VISITORS

Like most website operators, Audra Michelle Custodio collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Audra Michelle Custodio purpose in collecting non-personally identifying information is to better understand how Audra Michelle Custodio visitors use its website.
